Upon examination of Town highway usage and safety issues, and with the intent to provide lawful operators of all-terrain vehicles with suitable locations for their use, to encourage tourism but to discourage unlawful trespass upon public lands managed by the New York State Department of Environmental Conservation, private lands and unsafe operation of all-terrain vehicles, the Town Board will enact this law regulating all-terrain vehicles on town roads. This Town Board further finds that promoting opportunities for recreational use of all-terrain vehicles and the regulation of same is in the public benefit, will stimulate the local economy and will offer enjoyment to the citizens of the town and to others traveling to this area including tourists.
